**Conditions of Sale:**

- BREEDER warrants dog to be delivered in good health, current on all vaccinations, and free of worms, parasites, infection and/or diseases, as well as free from any genetic or life threatening defect to the best of BREEDER's knowledge preventing the dog from living a FULL and QUALITY life.
- BUYER agrees to follow up with a veterinary clinic within 72 HOURS of receiving this dog or the warranty of good health expires. All other conditions remain.
- If this DOG is from health tested/certified parents (Sire and Dam), good health includes warranty from hip dysplasia and any other genetic problems **that the parents are tested against** for up to 4 years of age. *This warranty only includes GENETIC difficulty, not anything occurring in the life of the dog (ex: strain of weight pulling, stress of jumping, etc.)*
- BUYER agrees to provide a safe home for their new dog, and will not use the animal for any illegal activities. BUYER will keep DOG in a well-protected area with adequate food, water, shelter, and attention. DOG should continue to be socialized and given proper training. If at any time the BUYER is found to be using the DOG for illegal activity, abusing, neglecting or abandoning this animal, **BREEDER reserves the right to regain possession of said dog through legal means.** We do not tolerate dog abuse, and WILL pursue legal action to regain rights to said DOG. BUYER also agrees that BREEDER can at any time available to BUYER; check up on/examine/visit DOG's quality of life.
- If at any time in this animal's life the BUYER can no longer care for the dog, we will gladly accept the dog back. ***If BUYER wants to Sell, Co-Own, or give away this dog, BREEDER must be notified first!!*** We do not want to see any of our dogs end up in shelters. By signing this agreement, you understand that if *at any time* during this animal's life you feel you cannot care for this animal, you will contact BREEDER first.
- BREEDER reserves the right to include our kennel name on the registration paperwork. Most dogs bought from BREEDER will already be permanently registered with a name we choose, and BUYER may choose any call name. - BUYER agrees to provide updates to BREEDER on the health and well-being of this DOG and any changes to contact information (i.e. phone number, email address, mailing address, etc.). BUYER also agrees to contact BREEDER with current information and pictures of said DOG AT LEAST once a year.
- *IF THE DOG SOLD HEREIN IS SOLD AS A PET QUALITY ANIMAL, THE DOG WILL BE SOLD WITH A SPAY/NEUTER CLAUSE TO PREVENT UNWANTED LITTERS. UKC LIMITED REGISTRATION WILL BE GIVEN.*

BUYER understands that if any of the terms mentioned in this agreement are not adhered to completely, BREEDER may take full legal possession of DOG named herein.**

Buyer releases Seller from any and all liabilities, and/or damages by fault of this dog at time of sale. In the event that a breach occurs, and the breaching party after notice, fails to remedy or cooperate, then this contract may be enforced in a court of law, and the prevailing party shall then be entitled to be made whole and/or recover for damages, costs, and attorney's fees along with surrendering said dog back to Seller. **The Seller and the Buyer each receive one signed copy of this contract. Any additional agreements made between Buyer and Seller shall be in an Amendment attached to this contract.**
