## **Conditions of Sale:**

□ BREEDER warrants PUP noted herein to be delivered in good health, current on all vaccinations, and free
of worms, parasites, infection and/or diseases, as well as free from any genetic or life threatening defect to the
best of BREEDER's knowledge preventing the PUPPY from living a FULL and QUALITY life.
☐ BUYER agrees to follow up with a veterinary clinic within 48 HOURS of receiving this PUPPY or the
warranty of good health expires. All other conditions remain. At this time if it is found that the PUP has a
genetic defect, BREEDER will replace PUP with a puppy of similar quality if available. In the interest of
bettering the breed, BUYER will notify BREEDER of life threatening or disabling disease or defects during its
lifetime. Such diseases or defects include, but are not limited to: cancer, hip, elbow or other orthopedic issues,
heart or other internal organ conditions, cataracts, infertility, birthing difficulty, offspring with birth defects,
mental defects, etc. { CRKENNELS reserves the right to talk to the diagnosing vet. }
□ If the a fore mentioned PUPPY is from health tested/certified parents (Sire and Dam), good health includes
warranty from hip dysplasia and any other genetic problems that the parents are tested against for the period
of 24 months of age. This warranty only includes GENETIC difficulty, not anything occurring in the life of the
dog (ex: strain of weight pulling, stress of jumping, etc.)
□ BREEDER does not guarantee the final size or weight of this puppy. Factors such as not de-worming or
vaccinating, poor nutrition, and even lack of mental stimulation/exercise could harm the animal's rate of
growth. We also do not guarantee that a PUP will be fit for breeding or will place in the show ring, even if sold
for such a purpose.
$\hfill \square$ BUYER agrees to provide a safe home for their new PUP, and will not use the pup for any illegal activities.
BUYER will keep PUPPY in a well-protected area with adequate food, water, shelter, and attention. PUPPY
should continue to be socialized and given proper training. If at any time BUYER is found to be using the
$\hbox{PUP for illegal activity, abusing, neglecting or abandoning this puppy, BREEDER reserves the right to}\\$
regain possession of said PUP through legal means. We do not tolerate dog abuse, and WILL pursue legal
action to regain rights to said animal. BUYER also agrees that BREEDER can at any time available to BUYER;
check up on/examine/visit PUPPY's quality of life.
□ <b>BUYER agrees that no refunds will be given.</b> If for any reason it is necessary, a return of the PUP for a
new pup will be given if one is available, or your money will transferred to any available breeding of equal
value. If BUYER is interested in a better quality breeding, BUYER has the option to pay difference in pup price
$\sqsupset$ If at any time in this animal's life the BUYER can no longer care for the PUPPY, we will gladly accept the pup
back. If BUYER wants to Sell, Co-Own, or give away this puppy, BREEDER must be notified first!! We
do not want to see any of our dogs end up in shelters. By signing this agreement, you understand that if at any
time during this animal's life you feel you cannot care for this animal, you will contact BREEDER first.
$\square$ BREEDER reserves the right to include our kennel name on the puppy registration paperwork. Most puppies
bought from BREEDER will already be permanently registered with a name we choose, and BUYER may
choose any call name.
