BITCH'S REQUIREMENTS:

- 1) The Bitch must be *at least* 12 months of age.
- 2) Bitch should be registered with the UKC, ABKC and/or ADBA. DNA Profiled is a plus but not required.
- 3) The Bitch must have no major disqualifying faults as defined in the Breed Standard for AMERICAN BULLIES AND/OR AMERICAN PIT BULL TERRIERS.
- 4) The Bitch **MUST** be of sound, stable temperament. Human aggression as well as unnaturally high animal aggression **WILL NOT** be tolerated.
- 5) For Maiden Bitches (never bred) and/ or Seasoned Bitches with AI's , the following is necessary:
 - a. Copy of 4+ Generation Pedigree and Ownership (Front/Inside)
 - b. Recent UTD copies of all medical records (shots, de-worming, rabies)
 - c. Free of any Internal (Worms) and External parasites (Fleas)
- 6) For Seasoned Bitches (Bred 1+ times) with Natural Ties, the following is necessary:
 - a. Copy of 4+ Generation Pedigree and Ownership (Front/Inside)
 - b. A Negative Brucellosis test issued no more than 10 days prior to breeding
 - c. A Negative Babesia test issued no more than 14 days prior to breeding
 - d. Recent UTD copies of all medical records (shots, de-worming, rabies)
 - e. Free of any Internal (Worms) and External parasites (Fleas)
- 7) CURRENT OWNER'S NAME/CO-OWNER'S NAME SHOULD MATCH THE NAME ON THE REGISTRATION PAPERS, AS WELL AS THE NAME ON THIS CONTRACT.

- Stud Owner reserves the right to have litter picks *in lieu of* a stud fee. Stud Owner also reserves the right to pick(s) of the litter for a *lower* stud fee. Stud Owner agrees to make pick(s) by/no later than _____ weeks of age.

- To be paid in full when bitch is delivered to stud owner and contract for breeding is signed. Receipt will be attached. The fee is Non-Refundable, and is only Transferrable for the following reasons:
 - 1. Missed heat
 - 2. Problems with Bitch/Stud (Illness, etc.)

- To be paid in 3 Installments:

 - 3. \$ _____ Remainder of Balance due when Bitch is picked up. *BITCH WILL NOT BE RELEASED WITHOUT STUD FEE AND/OR KEEPS FEE BEING PAID IN FULL!!

Please bring all copies of signed contracts when picking up females.

CONDITIONS:

- STUD OWNER LISTED ABOVE warrants that no less than 3 natural tie or Artificial Inseminations will occur, and that viable, live sperm are found in the bitch immediately after mating.
- If the bitch fails to conceive, a return service at no charge will be provided if the Bitch owner notifies us within 65 days that no puppies were whelped. If returned to re-breed at next heat, and again no pups are conceived, Stud owner is released from this agreement, NO REFUNDS!
- Two (2) live puppies are considered a whelp, and there is no further obligation from Stud owner. If the bitch does not whelp at least 2 live puppies, a free stud service will be provided to the original bitch or a mutually agreed upon bitch, at a time agreeable to both parties.
- If breeding is for *reduced stud fee and a pup or just a puppy* back and the bitch only whelps 1 puppy, bitch owner has 2 options:
 1. Pay FULL stud fee (see above) minus cash already paid, and keep the pup. A repeat breeding will be offered after payment of full stud fee.
 2. Give pup to Stud Owner and a repeat breeding to SAME bitch will be given, and all puppies will belong to Bitch Owner. No further obligation from Stud Owner.
- All transportation charges and veterinary expenses will be the responsibility of the bitch owner. There is no boarding charge for the 1st 10 days, after which the charge will be \$5 a day. This fee includes all the daily necessary care. *All food is to be provided by Bitch owner.*
- Stud Owner will aid the Bitch owner in the placing of puppies that result from this breeding into good homes if needed. Breeding will be placed under breeding page in Stud Owner's website, and puppies available can be placed on For Sale page as well if needed.
- Stud Owner reserves the right to include our kennel name, Cajun Royalty Kennels, or any variations thereof, on any puppy's permanent registration papers that is received by Stud Owner as payment of a stud fee.
- The Bitch owner agrees that all Pet Quality puppies will be sold with limited/no registration and on a spay/neuter agreement.
- Bitch owner agrees that no puppy resulting from this breeding will be disposed of through pet stores, puppy mills/commercial breeders, and puppy brokers or "resale" operations.
- **The Bitch owner agrees to notify Stud owner of any hereditary or genetic defect during their lifetimes that the Bitch owner becomes aware of.**
- Any damages to Stud Owner's property by bitch due to lack of training will be charged to bitch owner on the day bitch is picked up from Stud Owner. ***Please bring all copies of signed contracts when picking up females***
- Bitch will not be released until Stud fee and all money owed is paid in full. If I have to hold the bitch until she whelps I will take my pick(s) that I am owed, as well as another pick (but no more than 2) to cover all expenses and monies owed. If Stud Owner is receiving a puppy back, litter registration will not be signed until that pup is picked and delivered to stud owner ***no later*** than 10 weeks.

_____ BITCH OWNER WARRANTS THAT THIS BITCH HAS NOT BEEN EXPOSED TO ANY STUD DOG PRIOR TO HER ARRIVAL AT STUD OWNER'S HOME, AND THAT SHE WILL BE PROTECTED FROM SUCH EXPOSURE AFTER HER RETURN HOME.
